Board Business or Staff Business? - An Agenda that Works

Find out how to focus the board's limited meeting time on its main responsibilities, rather than on staff activity that can and should be delegated to the superintendent. Ensuring that the board, in its meetings, works on the right tasks is the job of a forward thinking board and a well constructed meeting agenda. Most school board meeting agendas are originated by staff, with board members adding items on an ad hoc basis. Not surprisingly, meetings tend to focus on the work of staff, in spite of the fact that boards, as part-time school leaders, have precious little time to devote to their own work.

What is Staff Business?

- Achieve end results directed by the Board on behalf of the Community
- Comply with policy limitations
